PENJELASAN

1. DAERAH PENCATATAN

Daerah pencatatan statistik dalam publikasi ini meliputi pelabuhan-pelabuhan yang berada di wilayah Kalimantan Timur.

2. SUMBER DATA

Data ekspor dikumpulkan berdasarkan dokumen ekspor/ Pemberitahuan Ekspor Barang (PEB) yang diisi oleh Eksportir dan telah diberikan izin muat oleh Bea dan Cukai serta dilegalisir oleh Bank Devisa.

3. SISTEM PERDAGANGAN

Pencatatan Statistik perdagangan luar negeri menggunakan sistem perdagangan umum (*general trade*) dimana pencatatan dilakukan dari dokumen PEB yang dimuat dari pelabuhan dan bandara di seluruh wilayah Indonesia termasuk kawasan berikut.

4. RUANG LINGKUP

⇒ Pencatatan Statistik Ekspor meliputi seluruh barang-barang yang keluar dari wilayah Kalimantan Timur yang bersifat komersial maupun bukan komersial seperti bantuan barang kredit lunak, hadiah dan sebagainya.

⇒ Ekspor kapal laut dan pesawat udara termasuk dalam statistik ekspor, sedangkan ekspor bunker oil untuk kapal tidak tercatat dalam publikasi ini.

⇒ Barang-barang yang diolah di luar negeri tetap dicatat sebagai ekspor, meskipun hasil olahan barang tersebut akan kembali masuk ke wilayah Kalimantan Timur.

⇒ Barang-barang di bawah ini tidak termasuk di dalam statistik ekspor

a. Pakaian & barang-barang perhiasan penumpang.

- b. Barang-barang yang dikirim untuk perwakilan Indonesia di luar negeri.
- c. Barang-barang untuk ekspedisi dan ekshibisi/pameran.
- d. Pembungkus/peti kemas untuk diisi diluar negeri.
- e. Uang dan Surat-surat berharga.
- f. Barang-barang contoh.
- g. Barang-barang yang dikirim keluar negeri untuk diperbaiki.

5. SISTEM PENGOLAHAN

Data dalam publikasi ini mencakup dokumen-dokumen Ekspor tahun 2016 yang diterima oleh Badan Pusat Statistik sejak awal Januari 2016 sampai dengan 31 Desember 2016. Sistem pengolahan menggunakan “*Carry Over*”. Dengan metode ini dokumen-dokumen dari daerah ditunggu selama satu bulan setelah bulan berjalan. Dokumen-dokumen yang datang terlambat akan dimasukkan dalam pengolahan bulan berikutnya. Metode “*Carry over*” ini sangat membantu mempercepat pengolahan data, disamping itu telah diteliti bahwa metode ini tidak begitu berpengaruh terhadap ekspor yang disebabkan “*carry over*” berikutnya.

6. KLASIFIKASI JENIS BARANG

Penggolongan barang didalam publikasi ini menggunakan Klasifikasi Tarif Indonesia 2012 yang didasarkan atas *Harmonized System (HS)*.

7. PERIODE REFERENSI

Periode penentuan ekspor adalah tanggal diberikannya izin muat barang tersebut oleh pejabat Bea & Cukai setelah diadakan pemeriksaan seperlunya.

8. *NILAI BARANG*

Nilai barang yang dicatat untuk statistik Ekspor adalah nilai FOB (US\$).

9. *NEGARA TUJUAN*

Yang dimaksud dengan negara tujuan adalah negara dimana barang tersebut akan dikonsumsi / diperdagangkan.

10. *SATUAN BARANG*

Sejak tahun 1975 ekspor disajikan dalam berat bersih (Kg) meskipun demikian untuk beberapa jenis barang disajikan pula buah, ekor, lembar, liter, dozen, pasang, unit dan sebagainya.

11. *PELABUHAN EKSPOR*

Yang dimaksud dengan pelabuhan ekspor adalah pelabuhan dimana surat izin muat tersebut dikeluarkan.

EXPLANATORY NOTES

1. AREA OF RECORDINGS

The statistics recording area in this publication covers the entire territory of the Kalimantan Timur.

2. SOURCE OF DOCUMENTS

The data compiled based on export documents/Export Declaration (PEB), filled out by the Exporters approved by the Customs & Excises and legalized by foreign exchange bank.

3. TRADE SYSTEM

Recording of Foreign Trade Statistics apply the general trade system, where the documents recorded from the whole port in Indonesia including bounded warehouse.

4. COVERAGE

⇒ *The recording Export statistics covers all goods leaving the territory of the Kalimantan Timur, both the commercial, as well as non commercial goods, such as goods with soft loans, grants/gifts, etc .*

⇒ *Ocean going ships and air planes are included in the statistics, while the export of bunker oil for ships is not presented in this publication.*

⇒ *Goods processed abroad, are still recorded as export although the results of this processing will return to, and enter on the territory of the East Kalimantan.*

⇒ *The following goods were not included in the statistics :*

- a. *Clothes and jewelry of passangers.*
- b. *Goods exported for the Indonesian representative abroad.*
- c. *Goods for expeditions and exhibition/shows.*
- d. *Packings/containers to be filled abroad.*

- e. *Banknotes and securities*
- f. *Sample goods*
- g. *Repaired goods*

5. PROCESSING SYSTEM

The data in this publication cover export documents of 2016 received by BPS-Statistics of Indonesia since the beginning of January 2016 through December 31, 2016. The carry over system is applied in this processing.

The deadline of a certain month is one month after the reference period, which means the end of the following month. The documents accepted after the deadline is considered as document of the following month. The method of carry over was very helpful to speed up data processing, beside that it was researched that the method was not significantly affected by the carry over data.

6. COMMODITY CLASSIFICATION

The classification of goods in this publication applies the 2012 Indonesia Tariff Classification, which is based on the Harmonized System (HS).

7. REFERENCE PERIOD

The period for export determination is the date of issuance of the Goods Loading Permit by the Customs & Excises official, after the necessary examination had been conducted.

8. COMMODITY VALUATION

The goods value recorded for the Export Statistics, is the FOB value (US\$).

9. COUNTRY OF DESTINATION

Country of destination is the country known at the time of dispatch to be the final country where goods are to be delivered

10. UNIT OF COMMODITY

Since 1975, export has been presented in net weight (kg); nevertheless, several types of goods are also presented in piece, sheet, litre, dozen pairs, units, etc.

11. PORT OF EXPORT

Port of export is the port where the Loading permit is issued.

ULASAN SINGKAT

A. Pendahuluan

Perdagangan luar negeri merupakan sektor ekonomi yang sangat berperan dalam menunjang pembangunan. Dari kegiatan ekspor dapat diperoleh devisa yang merupakan salah satu sumber dana untuk pembangunan.


Untuk meningkatkan ekspor, pemerintah telah mengeluarkan serangkaian kebijaksanaan seperti paket deregulasi. Inti dari paket deregulasi adalah pemerintah memperluas cakupan kelompok komoditi yang mendapat fasilitas dalam kerangka Perusahaan Eksporir Tertentu (PET).

Pada tahun 2016 kegiatan perdagangan luar negeri Kalimantan Timur khususnya ekspor mengalami penurunan sebesar 20,76 persen. Penurunan nilai ekspor Kalimantan Timur pada tahun 2016 apabila diamati dari golongan barang, disebabkan oleh penurunan barang-barang migas sebesar 41,04 persen dan non migas sebesar 9,00 persen terhadap tahun sebelumnya.

B. Perkembangan Ekspor

Perkembangan nilai ekspor Kalimantan Timur selama lima tahun terakhir rata-rata mengalami penurunan. Jika dilihat dari sektor, perkembangan sektor migas mengalami penurunan dari tahun 2012 sampai tahun 2016. Sedangkan perkembangan sektor non migas mengalami peningkatan pada tahun 2013. Selebihnya non migas juga mengalami penurunan.

Grafik 1. Perkembangan Nilai Ekspor Provinsi Kalimantan Timur, Tahun 2012 - 2016




C. Ekspor Kalimantan Timur Tahun 2016

Ekspor Kalimantan Timur tahun 2016 dimuat melalui 14 (empat belas) pelabuhan yang ada di Kalimantan Timur. Dari dua puluh pelabuhan ekspor tersebut bila diamati dari peran masing-masing pelabuhan, maka pelabuhan Bontang merupakan pelabuhan yang memuat barang ekspor terbesar pada tahun 2016 yakni sebesar 29,56 persen dari total nilai ekspor Kalimantan Timur, atau senilai US\$ 4,10 milyar dengan komoditi ekspor terbesar berupa komoditi migas. Pelabuhan yang memuat komoditi ekspor terbesar kedua dan ketiga adalah pelabuhan Samarinda dan Tanjung Bara, KL dengan nilai ekspor sebesar US\$ 3,52 milyar dan US\$ 2,60 milyar atau 25,45 persen dan 18,74 persen dari total nilai ekspor Kalimantan Timur tahun 2016. Selebihnya dimuat dari pelabuhan-pelabuhan lainnya yang dapat dilihat pada Tabel A.

Menurut Pelabuhan Muat Utama, Tahun 2016 (Persen)**




Barang-barang ekspor Kalimantan Timur tahun 2016 ditujukan ke berbagai negara di lima benua. Benua Asia merupakan tujuan ekspor terbesar dengan nilai mencapai US\$ 13,15 milyar atau sebesar 94,95 persen dari total nilai ekspor Kalimantan Timur. Berikutnya benua Eropa dan

Afrika masing-masing senilai US\$ 0,33 milyar dan US\$ 0,23 milyar atau sebesar 2,36 persen dan 1,65 persen. Selebihnya di ekspor ke benua Amerika dan Australia masing-masing senilai US\$ 109,21 juta dan US\$ 35,19 juta.

Menurut negara tujuan ekspor, maka Jepang merupakan negara tujuan ekspor terbesar Kalimantan Timur dengan nilai US\$ 2,96 milyar atau sebesar 21,38 persen dari total nilai ekspor. Kemudian disusul oleh negara

Tiongkok dan India masing-masing dengan nilai ekspor sebesar US\$ 2,20 milyar dan US\$ 2,19 milyar atau sebesar 15,89 persen dan 15,80 persen.

Menurut 21 golongan barang *Harmonized System (HS)*, produk mineral adalah golongan barang yang paling dominan diekspor dari Kalimantan Timur. Pada tahun 2016 produk mineral nilai ekspornya mencapai US\$ 12,61 milyar atau sebesar 91,01 persen dari total nilai ekspor Kalimantan Timur. Golongan barang dengan nilai ekspor terbesar berikutnya adalah produk industri kimia senilai US\$ 620,61 juta (4,48%), Kayu, barang dari kayu, barang anyaman sebesar US\$ 303,61 juta (2,19%), Lemak, minyak, malam nabati dan hewani sebesar US\$ 266,58 juta (1,92%) dan Mesin, perlengkapan, listrik, elektronika senilai US\$ 29,28 juta (0,21%). Di luar lima golongan barang tersebut, golongan barang lainnya memiliki total nilai ekspor sebesar US\$ 25,55 juta.

Selain berdasarkan 21 golongan barang, ekspor Kalimantan Timur bisa diamati menurut jenis barangnya (HS). Jenis barang ekspor terbesar dari Kalimantan Timur adalah *Bituminous coal: coking coal* yakni sebesar 28,57 persen dengan nilai US\$ 3,96 milyar, disusul oleh *Other coal, whether or not pulverised but not agglomerated* dan *Liquid natural gas (LNG)* masing-masing senilai US\$ 3,33 milyar dan US\$ 2,78 milyar atau sebesar 24,06 persen dan 20,08 persen dari total nilai ekspor Kalimantan Timur tahun 2016.

BRIEF DESCRIPTION

A. Introduction

Foreign trade is an economic factor which support the National Development. From the Export activities, the foreign exchange can be obtained which is regarded as one of the financial sources for development activities.


To increase the export, the Government has stipulated a set of policy like the deregulate package. The focus of the deregulates package is that Government expands the range of commodity group for some specific manufacturing export.

In 2016, Kalimantan Timur foreign trade activities, especially export, experienced to decreased by 20,76%. Decline in value of exports of Kalimantan Timur in the year 2016 when observed from the commodity group, caused by the decline in oil and gas goods amounted to 41,04% and non oil (expecially) amounted to 9,00% againts the previous year.

B. Export Development

During last five years, the export value was decreasing over time. This due to a significant decrease in oil & gas export value. Graph shows that a slight increase in non oil & gas export value in 2013 could not contribute in creating growth in the total of export value. From 2013, both oil & gas sector and non oil & gas sectors gradually declines.

Graph 1. Trend of Kalimantan Timur Export Value, 2012 – 2016




C. Kalimantan Timur Export in 2016

In the year of 2016, Kalimantan Timur export was loaded through 14 ports available in Kalimantan Timur. Out of 14 export ports, as viewed from each port activities, Bontang Port was regarded as the biggest port containing of 29,56% of export commodity, which reached US\$ 4,10 billion, was oil and gas material. Port that contains the scond largest export commodity and the thrid is the port of Samarinda and Tanjung Bara, KL which US\$ 3,52 billion and US\$ 2,60 billion or 25,45% and 18,74% of the total expor value of Kalimantan Timur in 2016. The remining export commodity was loaded by other ports as shown in Table A.

Graph 2. Kalimantan Timur Export Value by Major Port, 2016 (%)




In 2016, the export commodity of Kalimantan Timur were sent to many countries in five continents. Asia Continent was regarded as the largest export destination with the total value US\$ 13,15 billion or 94,95% from the total export value of Kalimantan Timur. The next were Europe and Africa which reached US\$ 0,33 billion and US\$ 0,23 billion or 2,36% and 1,65%. And the remaining continent

of export destination was America and Australia which reached US\$ 109,21 million and US\$ 35,19 million respectively.

As based on the destination countries, Japan was found as the largest one, with the total of value of US\$ 2,96 billion or 21,38% of the total export value. The

next were Tiongkok and India US\$ 2,20 billion and US\$ 2,19 billion or 15,89% and 15,80% respectively, followed by other countries.

As based on 21 HS Commodity group, mineral products as the largest one with the total value US\$ 12,61 billion or 91,01 persen of the export total. The next were product of chemical or allied industries which US\$ 620,61 million (4,48%), Wood and its articles, plaiting materials which US\$ 303,61 million (2,19%), Fats Oils, waxes of animals/vegetable which US\$ 266,58 million (1,92%) and Machinery, electrical, electronic equipments which US\$ 29,28 million (0,21%). Outside of these five commodity group, other commodity group have a total value of eksport amounted to US\$ 25,55 million.

Out of the total export, the largest of export commodity was Bituminous coal: coking coal (28,57%) which reached US\$ 3,96 billion and followed by Other coal, whether or not pulverised but not agglomerated and Liquid natural gas (LNG) which reached US\$ 3,33 billion and US\$ 2,78 billion or 24,06% and 20,08% respectively.
