KATA PENGANTAR

Ekspor-Impor Propinsi Banten 2006 merupakan publikasi lanjutan mengenai Statistik Ekspor dan Impor di Propinsi Banten yang diterbitkan setiap tahun oleh BPS Propinsi Banten. Data yang disajikan dalam publikasi ini mencakup data ekspor dan impor yang ada terjadi wilayah di Propinsi Banten melalui Pelabuhan Merak dan Pelabuhan Cigading selama Tahun 2006. Data dikelompokkan dalam 1 digit SITC, 2 digit HS dan 9 digit HS yang dirinci menurut berat bersih dan nilai selama tahun 2006. Disamping itu juga disajikan ekspor berdasarkan negara tujuan dan impor berdasarkan negara asal.

Mudah-mudahan Publikasi Ekspor-Impor Propinsi Banten Tahun 2006 ini dapat lebih melengkapi informasi mengenai Ekspor dan Impor di Propinsi Banten.

BAB I

PENDAHULUAN

1.1 Latar Belakang

Perdagangan luar negeri (ekspor dan impor) merupakan salah satu sektor yang dapat menjadi motor penggerak pembangunan ekonomi di Provinsi Banten yang secara umum memiliki keunggulan strategis yang tidak dimiliki daerah lainnya. Banten disamping sebagai daerah penyangga ibukota negara dengan segala konsekwensinya, juga sebagai jalur lintasan ekonomi Jawa Sumatera. Dengan letak yang strategis ini secara ekonomis memudahkan dibidang distribusi sekaligus pemasaran produksi.

Provinsi Banten memiliki fasilitas pelabuhan antar pulau dan antar negara yang dapat dijadikan alternatif persinggahan atau arus bongkar muat barang dan jasa apabila pelabuhan tanjung priuk kapasitasnya tidak memungkinkan lagi untuk dikembangkan. Dengan adanya pembangunan Pelabuhan Bojonegara diharapkan dapat lebih meningkatkan aktifitas ekspor impor di Banten.

Data tahun 2006 menunjukkan bahwa sektor perdagangan merupakan sektor terbesar ketiga yang menyerap tenaga kerja di Banten sebesar 21,65 persen dibawah sektor industri dengan 22,83 persen dan sektor pertanian sebesar 22,40 persen. Penyerapan tenaga kerja yang cukup besar ini tentu merupakan indikator yang menunjukkan besarnya kontribusi sektor perdagangan terhadap perekonomian Banten, khususnya dalam penyerapan tenaga kerja. Semakin cepat perdagangan luar negeri berkembang akan semakin cepat pula pemulihan ekonomi tercipta. Seorang ahli ekonomi (Gillis et al 1987) menyatakan bahwa sektor perdagangan dapat berfungsi sebagai

engine of development yaitu sektor yang akan menggerakkan kegiatan-kegiatan sektor lainnya.

Untuk memacu peningkatan perdagangan luar negeri dibutuhkan daya tarik investasi, khususnya dalam persaingan sesama daerah yang berusaha menarik investor agar berinvestasi di daerahnya. Untuk memenangkan persaingan ini, perlu didukung oleh sarana dan prasarana yang kondusif bagi masuknya investasi asing. Hal ini dapat ditempuh melalui kemudahan dalam melakukan perizinan investasi (birokrasi yang tidak berbelit-belit), bea masuk khususnya bahan baku dan penolong maupun barang modal yang tidak terlalu mahal, promosi dagang yang intensif dan berkesinambungan. Hal yang tidak kalah pentingnya adalah adanya jaminan keamanan bagi investasi yang masuk ke suatu wilayah.

Selain upaya yang telah disebutkan, peningkatan perdagangan luar negeri juga bisa ditempuh melalui pembinaan dan pemberdayaan para pengusaha lokal. Upaya yang telah diupayakan antara lain dengan memberikan insentif kemudahan kredit bagi produsen yang akan melakukan ekspor, penurunan pajak ekspor/impor, penyebarluasan informasi pasar di luar negeri dan penyederhanaan (deregulasi) berbagai peraturan kepabeanan.

Upaya lainnya adalah dengan memilih jenis komoditi yang dapat dijadikan sebagai andalan ekspor, terutama ekspor non migas. Untuk itu diperlukan adanya usaha diversifikasi komoditi-komoditi yang mempunyai keunggulan kompetitif (*Competitive advantage*) di pasar luar negeri serta komoditi yang berbasiskan bahan baku lokal (*resource based industry*) karena ternyata usaha jenis inilah yang tahan terhadap terpaan badai krisis.

1.2 Maksud dan Tujuan

Publikasi Ekspor Impor Banten Tahun 2006 mempunyai maksud dan tujuan sebagai berikut :

- Monitoring dan mendapatkan informasi mengenai kegiatan ekspor impor Banten.
- Menyajikan data ekspor impor Banten yang dirinci menurut jenis komoditi dan negara tujuan untuk ekspor serta negara asal untuk impor.
- Menganalisis secara kuantitatif perkembangan ekspor impor Banten.
- Mencari komoditi ekspor yang prospektif untuk dikembangkan dan potensinya belum digarap secara optimal.
- Sebagai dasar pola pengambilan kebijakan dalam mendorong serta memacu perdagangan luar negeri khususnya pertumbuhan ekonomi Banten.

1.3 Metodologi dan Konsep Definisi

1.3.1 Metode Pengumpulan Data

Data ekspor untuk keperluan penyajian ini dikumpulkan dari dokumen ekspor atau Pemberitahuan Ekspor Barang (PEB) yang diisi oleh eksportir dan telah disahkan oleh Bea dan Cukai. Sedangkan data impor dikumpulkan berdasarkan dokumen Pemberitahuan Impor Barang (PIB) yang diterima melalui Kantor Bea dan Cukai.

Untuk memperkirakan besarnya ekspor maupun impor yang benar-benar berasal dari dan ke Banten maka perlu dilakukan pengecekan terhadap dokumen-dokumen PEB dan PIB. Dalam dokumen PEB ada rincian mengenai propinsi asal barang. Berdasarkan rincian inilah diperoleh informasi besarnya ekspor yang benar-benar dilakukan atau merupakan ekspor dari produk yang dihasilkan oleh unit usaha yang berdomisili di wilayah Banten. Sedangkan besarnya nilai impor yang digunakan khusus untuk wilayah Banten, pengumpulan datanya sulit terpisahkan dari

keseluruhan impor yang masuk melalui wilayah Banten. Importir yang melakukan impor pun tidak mampu untuk mengetahui daerah mana yang menjadi *final destination* dari barang yang yang di impor melalui perusahaannya.

1.3.2 Metode Pengolahan Data

Pengolahan data menggunakan sistem *carry over*, yaitu dokumen PEB dan PIB ditunggu selama satu bulan berjalan. Sistem ini dimaksudkan untuk mempercepat pengolahan dan tidak begitu berpengaruh terhadap total ekspor-impor bulan berikutnya, maupun secara total dalam satu tahun.

1.3.3 Konsep Definisi

Dalam rangka memberikan gambaran yang jelas dan mengurangi perbedaan persepsi mengenai beberapa variabel dalam publikasi ini maka diperlukan adanya konsep definisi diantaranya :

- a. **Perdagangan luar negeri** adalah perdagangan yang melewati batas teritorial suatu negara. Dalam hal ini, perdagangan luar negeri tersebut mencakup ekspor maupun impor.
- b. **Ekspor** adalah kegiatan perdagangan dengan cara melakukan penjualan barang-barang dari dalam negeri ke luar negeri.
- c. **Impor** adalah kegiatan perdagangan dengan cara mendatangkan barang-barang dari luar negeri untuk dijual/digunakan di dalam negeri.
- d. **Eksportir Banten** adalah pengusaha yang bergerak di bidang ekspor barang yang berkedudukan atau terdaftar di Banten.
- e. **Eksportir produsen** adalah pengusaha yang mengekspor barang-barang hasil produksi perusahaannya sendiri.

- f. **Eksportir non produsen** adalah pengusaha yang mengekspor barang-barang hasil produksi perusahaan lain.
- g. **Importir Banten** adalah pengusaha yang bergerak di bidang impor barang yang berkedudukan atau terdaftar di Banten.
- h. **Nilai barang yang dicatat untuk statistik ekspor** adalah nilai Free On Board/FOB (dalam satuan dollar Amerika) sedangkan nilai barang yang dicatat untuk statistik impor adalah nilai Cost, Insurance & Freight/CIF (dalam satuan dollar Amerika).
- i. **Negara Asal** adalah negara dimana barang-barang tersebut dikeluarkan setelah diperiksa pejabat Bea dan Cukai sesuai dengan peraturan yang berlaku.
- j. **Negara Tujuan** adalah negara dimana barang tersebut diperkirakan akan dikonsumsi/diperdagangkan
- k. **Pelabuhan Muat** merupakan pelabuhan dimana surat ijin muat barang ekspor itu dikeluarkan.
- l. **Pelabuhan Bongkar** merupakan pelabuhan dimana barang-barang impor dibongkar dari kapal pengangkut yang berasal dari luar negeri.
- m. **Periode referensi penentuan ekspor** adalah tanggal diberikannya ijin muat barang tersebut oleh pejabat Bea dan Cukai setelah diadakan pemeriksaan seperlunya.
- n. **Periode referensi penentuan impor** adalah tanggal penyelesaian oleh pejabat Bea dan Cukai yang terdapat dalam dokumen impor..
- o. **Propinsi Asal Barang** adalah wilayah administrasi setingkat propinsi yang menunjukkan tempat dimana barang tersebut dihasilkan atau diproduksi. .
- p. **Satuan barang ekspor dan impor** dalam publikasi ini disajikan dalam berat bersih Kilogram (kg) atau kelipatannya.

1.4 Ruang Lingkup

Data ekspor yang digunakan dan dianalisis pada publikasi ini adalah data dari semua jenis barang yang keluar dari wilayah Banten (pelabuhan muat), baik bersifat komersial seperti barang/bantuan kredit, hadiah, hibah dan sebagainya untuk tujuan luar negeri. Kegiatan ekspor ini dilakukan oleh eksportir yang berkedudukan (terdaftar) di Wilayah Banten, baik eksportir produsen maupun non produsen/eksportir umum.

Pencatatan data impor adalah semua barang yang masuk dari luar negeri melalui pelabuhan wilayah Banten (pelabuhan bongkar) tanpa memperhatikan lokasi pelaku importir.

BAB II

STATISTIK EKSPOR

2.1 Ekspor Berdasarkan Pelabuhan Muat

Selama kurun waktu tiga tahun terakhir, nilai ekspor melalui pelabuhan muat di Wilayah Banten selalu mengalami fluktuasi. Fluktuasi ini bukan semata-mata akibat perubahan kinerja ekspor, tetapi sebagian besar akibat depresiasi nilai tukar rupiah. Hal tersebut terlihat dari tahun 2004-2006, perubahan bobot ekspor lebih rendah dibandingkan nilai ekspor itu sendiri. Pada tahun 2006 terjadi peningkatan bobot sebesar 49,11 persen dari tahun sebelumnya, tetapi dari segi nilainya terjadi peningkatan hanya sebesar 14,46 persen. Untuk kurun waktu 2004-2006 peningkatan bobot ekspor sejalan dengan peningkatan nilainya yaitu masing-masing 14,76 persen untuk bobot dan 17,73 persen untuk nilainya.



Ekspor Propinsi Banten pada tahun 2006 mencapai nilai US\$ 812.636.545 dengan volume sebesar 1.782.152,173 ton. Dibandingkan dengan tahun 2005, nilai ekspor melalui pelabuhan di Provinsi Banten mengalami peningkatan sebesar 14,46 persen dan volume eksport juga meningkat sebesar 49,11 persen

Bila dibandingkan setiap bulannya, ekspor Propinsi Banten tahun 2006, Bulan Desember mengalami nilai ekspor tertinggi yaitu sebesar US\$ 144.640.255 dengan volume sebesar 271.206,965 ton. Nilai ekspor terendah pada Bulan Januari sebesar US\$ 41.515.193 dengan volume sebesar 64.325,27 ton. Rata-rata nilai ekspor per bulan selama tahun 2006 sebesar US\$ 67.719.712 dengan volume rata-rata 148.512,681 ton.

Dari data menurut pelabuhan muat, nilai ekspor yang melalui Pelabuhan Merak selama tahun 2006 sebesar US\$ 525.135.374 atau meningkat 1,16 persen dari tahun sebelumnya dengan volume eksport sebesar 835.827,981 ton (naik 2,68 persen). Sedangkan nilai eksport

melalui Pelabuhan Cigading US\$ 287.501.171 atau naik sebesar 50,60 persen dari tahun sebelumnya dengan volume sebesar 946.324,192 ton (naik 148,30 persen).

2.2 Ekspor Berdasarkan Golongan Barang

Nilai ekspor tertinggi selama tahun 2006 berdasarkan golongan barang adalah pada golongan Bahan Mentah (Crude Materials, Inedible) yang mencapai 39,44 persen dengan nilai sebesar US\$ 320.505.822 dan volume ekspor sebesar 880.109,662 ton (49,38 persen). Sedangkan nilai ekspor terendah adalah golongan bahan kimia (Chemical) sebesar US\$ 127.103 atau hanya 0,02 persen dari total nilai ekspor dengan volume ekspor sebesar 81,01 ton.



2.3 Ekspor Berdasarkan Negara Tujuan

Ekspor Propinsi Banten berdasarkan 5 negara tujuan yang terbesar adalah ekspor ke negara China sebesar US\$ 164.627.674 (turun 37,48 persen), Malaysia sebesar US\$ 139.536.165 (turun 0,68 persen), Australia sebesar US\$ 90.854.811 (naik 1323,59 persen), India sebesar US\$ 71.465.899 (naik 109,76 persen) dan Thailand sebesar US\$ 52.911.637 (turun 2,32 persen).

Negara tujuan ekspor Banten pada tahun 2006 ternyata banyak ke negara-negara kawasan Asia khususnya Non ASEAN sebesar 41,12 persen dan sesama negara ASEAN sebesar 33,26 persen. Sedangkan ekspor Banten ke Kawasan Amerika hanya sebesar 5,36 persen serta untuk kawasan Eropa sebesar 7,98 persen, kawasan Australia sebesar 11,18 persen dan kawasan Afrika sebesar 1,10 persen.

BAB III

STATISTIK IMPOR

3.1 Impor Berdasarkan Pelabuhan Bongkar

Perkembangan impor Banten berdasarkan pelabuhan bongkar periode 2004-2006 cenderung mengalami peningkatan secara nilainya sedangkan secara bobot berfluktuasi. Penurunan bobot impor terjadi pada tahun 2005 dibandingkan dengan tahun 2004 sebesar 21,14 persen begitu pula dengan nilainya yang turun sebesar 7,14 persen. Pada tahun 2006, impor Banten menunjukkan peningkatan baik secara bobot maupun nilainya.



Nilai impor melalui pelabuhan di Provinsi Banten selama Tahun 2006 meningkat dari US\$ 3.326.285.143 menjadi US\$ 4.426.015.662 (naik 33,06 persen) dengan volume sebesar 10.633.024,746 ton atau naik sebesar 32,19 persen dari tahun sebelumnya.

Nilai Impor Propinsi Banten tahun 2006 per bulan yang terbesar terjadi pada Bulan Nopember dengan nilai sebesar US\$ 483.944.739 atau 10,93 persen dari total impor dengan volume sebesar 1.143.580,897 ton. Sedang nilai impor terendah terjadi pada Bulan Maret sebesar US\$ 282.859.721 atau 6,39 persen dari total impor dengan volume sebesar 601.529,826 ton.

Nilai impor Propinsi Banten tahun 2006 yang bongkar di Pelabuhan Merak sebesar US\$ 2.970.269.319 atau naik sebesar 35,07 persen dari tahun 2005 dengan volume impor sebesar 4.535.525,458 ton. Sedangkan melalui Pelabuhan Cigading, nilai impor Banten US\$ 1.455.746.343 atau naik 29,14 persen dari tahun sebelumnya dengan volume impor sebesar 6.097.499,288 ton.

3.2 Impor Berdasarkan Golongan Barang

Nilai impor Propinsi Banten tahun 2006 berdasarkan golongan barang yang terbesar terdapat pada golongan barang Bahan Mentah (*Crude Materials, Inedible*) sebesar US\$ 3.307.351.365 atau 74,73 persen dari total impor dengan volume sebesar 7.299.530,057 ton. Sedangkan golongan barang yang nilainya paling rendah adalah Makanan dan Binatang Hidup (*Food and Live Animals*) sebesar US\$ 3.236 dengan volume sebesar 1,446 ton. Secara keseluruhan impor Banten berdasarkan golongan barang nilainya naik kecuali untuk dua golongan barang nilainya turun antara lain hasil industri menurut bahan, serta mesin dan alat pengangkutan.

3.3 Impor Berdasarkan Negara Asal


Nilai impor Propinsi Banten berdasarkan 5 negara asal terbesar yaitu Singapore sebesar US\$ 1.160.809.141 (26,23 persen), United States sebesar US\$ 336.189.690 (7,60 persen), Saudi Arabia sebesar US\$ 374.309.571(8,46 persen), Malaysia sebesar US\$ 362.705.444 (8,19 persen) dan India sebesar US\$ 307.602.784 (6,95 persen).

Negara asal impor ke Banten pada tahun 2006 lebih banyak didominasi oleh negara-negara kawasan Asia, untuk negara Asia non ASEAN sebesar 33,13 persen dan sesama negara ASEAN sebesar 39,74 persen. Sedangkan impor dari negara kawasan Amerika sebesar 18,42 persen, kawasan Eropa sebesar 2,34 persen, kawasan Australia sebesar 5,34 persen dan kawasan Afrika sebesar 1,02 persen.

Bila dibandingkan nilai ekspor Banten terhadap nilai impornya masih terjadi defisit devisa. Nilai ekspor Banten yang sebesar US\$ 812.636.545 dengan nilai impor Banten yang mencapai US\$ 4.426.015.662 berarti terdapat defisit devisa sebesar US\$ 3.613.379.117 Jika dibandingkan tahun 2005, maka tahun 2006 terjadi peningkatan defisit devisa sebesar 38,11 persen artinya dengan nilai ekspor yang cukup meningkat, belum mampu mengurangi nilai impor yang masuk ke Provinsi Banten.

Pada dasarnya Provinsi Banten bisa mengurangi impornya bila produksi di dalam provinsi telah mampu memenuhi kebutuhannya sendiri.
