PREFACE


The 2021 Export Statistics of Kalimantan Timur is an annual publication, published by the BPS – Statistics of Kalimantan Timur.

PENJELASAN

EXPLANATORY NOTES

1. DAERAH PENCATATAN

Daerah pencatatan statistik dalam publikasi ini meliputi pelabuhan-pelabuhan yang berada di wilayah Kalimantan Timur.

2. SUMBER DATA

Data ekspor dikumpulkan berdasarkan dokumen ekspor/Pemberitahuan Ekspor Barang (PEB) yang diisi oleh Eksportir dan telah diberikan ijin muat oleh Bea dan Cukai serta dilegalisir oleh Bank Devisa.

3. SISTEM PERDAGANGAN

Pencatatan Statistik perdagangan luar negeri menggunakan sistem perdagangan umum (*general trade*) dimana pencatatan dilakukan dari dokumen PEB yang dimuat dari pelabuhan dan bandara di seluruh wilayah Indonesia termasuk kawasan berikat.

1. AREA OF RECORDINGS

The statistics recording area in this publication covers the entire territory of the Kalimantan Timur.

2. SOURCE OF DOCUMENTS

The data compiled based on export documents/Export Declaration (PEB), filled out by the Exporters approved by the Customs & Excises and legalized by foreign exchange bank.

3. TRADE SYSTEM

Recording of Foreign Trade Statistics apply the general trade system, where the documents recorded from the whole port in Indonesia including bounded warehouse.

4. RUANG LINGKUP

Pencatatan Statistik Ekspor meliputi seluruh barang-barang yang keluar dari wilayah Kalimantan Timur yang bersifat komersial maupun bukan komersial seperti bantuan barang kredit lunak, hadiah dan sebagainya.

Ekspor kapal laut dan pesawat udara termasuk dalam statistik ekspor, sedangkan ekspor bunker oil untuk kapal tidak tercatat dalam publikasi ini.

Barang-barang yang diolah di luar negeri tetap dicatat sebagai ekspor, meskipun hasil olahan barang tersebut akan kembali masuk ke wilayah Kalimantan Timur.

Barang-barang di bawah ini tidak termasuk di dalam statistik ekspor :

- a. Pakaian & barang-barang perhiasan penumpang.
- b. Barang-barang yang dikirim untuk perwakilan Indonesia di luar negeri.
- c. Barang-barang untuk ekspedisi dan ekshibisi/pameran.

4. COVERAGE

The recording Export statistics covers all goods leaving the territory of the Kalimantan Timur, both the commercial, as well as non commercial goods, such as goods with soft loans, grants/gifts, etc .

Ocean going ships and air planes are included in the statistics, while the export of bunker oil for ships is not presented in this publication.

Goods processed abroad, are still recorded as export although the results of this processing will return to, and enter on the territory of the East Kalimantan.

The following goods were not included in the statistics:

- a. *Clothes and jewelry of passangers.*
- b. *Goods exported for the Indonesian representative abroad.*
- c. *Goods for expeditions and exhibition/shows.*
- d. *Packings/containers to be filled abroad.*

- d. Pembungkusan/peti kemas untuk diisi diluar negeri.
- e. Uang dan Surat-surat berharga.
- f. Barang-barang contoh.
- g. Barang-barang yang dikirim keluar negeri untuk diperbaiki.
- e. Banknotes and securities
- f. Sample goods
- g. Repaired good

5. SISTEM PENGOLAHAN

Data dalam publikasi ini mencakup dokumen-dokumen Ekspor tahun 2021 yang diterima oleh Badan Pusat Statistik sejak awal Januari 2021 sampai dengan 31 Desember 2021. Sistem pengolahan menggunakan "Carry Over". Dengan metode ini dokumen-dokumen dari daerah ditunggu selama satu bulan setelah bulan berjalan. Dokumen-dokumen yang datang terlambat akan dimasukkan dalam pengolahan bulan berikutnya. Metode "Carry over" ini sangat membantu mempercepat pengolahan data, disamping itu telah diteliti bahwa metode ini tidak begitu berpengaruh terhadap ekspor yang disebabkan "carry over" berikutnya.

5. PROCESSING SYSTEM

The data in this publication cover export documents of 2021 received by BPS- Statistics of Indonesia since the beginning of January 2021 through December 31, 2021. The carry over system is applied in this processing. The deadline of a certain month is one month after the reference period, which means the end of the following month. The documents accepted after the deadline is considered as document of the following month. The method of carry over was very helpful to speed up data processing, beside that it was researched that the method was not significantly affected by the carry over data.

6. KLASIFIKASI JENIS BARANG

Penggolongan barang di dalam publikasi ini menggunakan Klasifikasi Tarif Indonesia 2022 yang didasarkan atas *Harmonized System (HS)*.

7. PERIODE REFERENSI

Periode penentuan ekspor adalah tanggal diberikannya izin muat barang tersebut oleh pejabat Bea & Cukai setelah diadakan pemeriksaan seperlunya.

8. NILAI BARANG

Nilai barang yang dicatat untuk statistik Ekspor adalah nilai FOB (US\$).

9. NEGARA TUJUAN

Yang dimaksud dengan negara tujuan adalah negara dimana barang tersebut akan dikonsumsi /diperdagangkan.

10. SATUAN BARANG

Sejak tahun 1975 ekspor

6. COMMODITY CLASSIFICATION

The classification of goods in this publication applies the 2022 Indonesia Tariff Classification, which is based on the Harmonized System (HS).

7. REFERENCE PERIOD

The period for export determination is the date of issuance of the Goods Loading Permit by the Customs & Excises official, after the necessary examination had been conducted.

8. COMMODITY VALUATION

The goods value recorded for the Export Statistics, is the FOB value (US\$).

9. COUNTRY OF DESTINATION

Country of destination is the country known at the time of dispatch to be the final country where goods are to be delivered.

10. UNIT OF COMMODITY

Since 1975, export has been

11. PORT OF EXPORT

Port of export is the port where the Loading permit is issued.

A. Pendahuluan

Perdagangan luar negeri merupakan sektor ekonomi yang sangat berperan dalam menunjang pembangunan. Dari kegiatan ekspor dapat diperoleh devisa yang merupakan salah satu sumber dana untuk pembangunan.

Untuk meningkatkan ekspor, pemerintah telah mengeluarkan serangkaian kebijaksanaan seperti paket deregulasi. Inti dari paket deregulasi adalah pemerintah memperluas cakupan kelompok komoditi yang mendapat fasilitas dalam kerangka Perusahaan Eksportir Tertentu (PET).

Pada tahun 2021 kegiatan perdagangan luar negeri Kalimantan Timur khususnya ekspor mengalami peningkatan sebesar 86,13 persen. Peningkatan nilai ekspor Kalimantan Timur pada tahun 2021 apabila diamati dari golongan barang, disebabkan oleh peningkatan yang signifikan sektor non migas sebesar 90,63 persen terhadap tahun sebelumnya.

A. Introduction

Foreign trade is an economic factor which support the National Development. From the Export activities, the foreign exchange can be obtained which is regarded as one of the financial sources for development activities.

To increase the export, the Government has stipulated a set of policy like the deregulate package. The focus of the deregulates package is that Government expands the range of commodity group for some specific manufacturing export.

In 2021, Kalimantan Timur foreign trade activities, especially export, experienced increased by 86,13 percent. The increase in value of exports of Kalimantan Timur in the year 2021 when observed from the commodity group, caused by the significant increase in non oil and gas (especially) amounted to 90,63 percent againts the previous year.


B. Perkembangan Ekspor

Perkembangan nilai ekspor Kalimantan Timur selama lima tahun terakhir rata-rata menunjukkan peningkatan. Pada tahun 2020 dan tahun 2021, seperti pada grafik yang ditampilkan, nilai ekspor pada tahun 2021 mengalami peningkatan sebesar 86,13 persen atau mencapai US\$ 24,16 miliar. Jika dilihat dari sektor, yang mengalami peningkatan yang signifikan adalah sektor non migas naik sebesar 90,63 persen atau mencapai US\$ 22,55 miliar.

B. Export Development

During last five years, the export value was increasing over time.. But in 2020 and 2021, as in the graph shown, the export value in 2021 experienced an increase of 86,13 percent or reaching US\$ 24,16 billion. When viewed from the sector, the non oil and gas sector increased by 90,63 percent or reached US\$ 22,55 billion.

C. Ekspor Kalimantan Timur Tahun 2021

Ekspor Kalimantan Timur tahun 2021 dimuat melalui 9 (sembilan) pelabuhan yang ada di Kalimantan Timur. Dari dua belas pelabuhan ekspor tersebut bila diamati dari peran masing-masing pelabuhan, maka pelabuhan Samarinda merupakan pelabuhan yang memuat barang ekspor terbesar pada tahun 2021 yakni sebesar 26,09 persen dari total nilai ekspor Kalimantan Timur, atau senilai US\$ 6,30 miliar dengan komoditi ekspor terbesar berupa komoditi non migas. Pelabuhan yang memuat komoditi ekspor terbesar kedua dan ketiga adalah pelabuhan Balikpapan dan Bontang dengan nilai ekspor sebesar US\$ 5,21 miliar dan US\$ 4,26 miliar atau 21,57 persen dan 17,61 persen dari total nilai ekspor Kalimantan Timur tahun 2021. Selebihnya dimuat dari pelabuhan-pelabuhan lainnya yang dapat dilihat pada Tabel A.

C. Kalimantan Timur Export in 2021


In the year of 2021, Kalimantan Timur export was loaded through 9 (nine) ports available in Kalimantan Timur. Out of twelve export ports, as viewed from each port activities, Samarinda Port was regarded as the biggest port containing of 26,09 percent of export commodity, which reached US\$ 6,30 billion, was non oil material. Port that contains the second largest export commodity and the third is the port of Balikpapan and Bontang which US\$ 5,21 billion and US\$ 4,26 billion or 21,57 percent and 17,61 percent of the total export value of Kalimantan Timur in 2021. The remaining export commodity was loaded by other ports as shown in Table A.

Barang-barang ekspor Kalimantan Timur tahun 2021 ditujukan ke berbagai negara di lima benua. Benua Asia merupakan tujuan ekspor terbesar dengan nilai mencapai US\$ 22,65 milyar atau sebesar 93,76 persen dari total nilai ekspor Kalimantan Timur. Berikutnya benua Amerika dan Eropa masing-masing senilai US\$ 0,57 milyar dan US\$ 0,39 milyar atau sebesar 2,36 persen dan 1,61 persen. Selebihnya di ekspor ke benua Afrika dan Australia masing-masing senilai US\$ 0,36 milyar dan US\$ 0,18 milyar atau 1,50 persen dan 0,77 persen.


In 2021, the export commodity of Kalimantan Timur were sent to many countries in five continents. Asia Continent was regarded as the largest export destination with the total value US\$ 22,65 billion or 93,76 percent from the total export value of Kalimantan Timur. The next were America and Europe which reached US\$ 0,57 billion and US\$ 0,39 billion or 2,36 percent and 1,61 percent. And the remaining continent of export destination was Africa and Australia which reached US\$ 0,36 billion and US\$ 0,18 billion respectively or 1,50 percent and 0,77 percent.

Menurut negara tujuan ekspor, maka China merupakan negara tujuan ekspor terbesar Kalimantan Timur dengan nilai US\$ 9,86 miliar atau sebesar 40,82 persen dari total nilai ekspor. 
