PENJELASAN***Explanatory Notes*****1. Daerah Pencatatan**

Daerah pencatatan dalam publikasi ini meliputi seluruh wilayah Republik Indonesia, kecuali wilayah bebas Batam untuk data impor dianggap sebagai "luar negeri".

2. Sumber Dokumen

Data Ekspor dan Impor dikumpulkan berdasarkan dokumen Pemberitahuan Ekspor Barang (PEB) dan dokumen Pemberitahuan Impor Barang (PIB) yang diisi oleh Eksportir/importir dan telah diberikan ijin muat/bongkar oleh Kantor Pelayanan Bea dan Cukai, dan selanjutnya melalui Bank Indonesia dikirim ke Badan Pusat Statistik (BPS).

3. Sistem Perdagangan

Pencatatan Stat. Perdagangan Luar Negeri menggunakan sistem perdagangan umum atau dengan sistem perdagangan khusus. Pencatatan Statistik Ekspor menggunakan sistem perdagangan umum sedang untuk Statistik Impor dengan menggunakan sistem perdagangan khusus dimana pencatatan dilakukan dari dokumen PEB dan PIB yang dimuat/dibongkar dari pelabuhan di seluruh wilayah Indonesia.

1. Area of Recording

The statistical recording area in this publication covers the entire territory of Republic Indonesia, except for free area Batam which is import data considered as "foreign."

2. Source of Document

The export and import statistics are compiled based on documents of Export Declaration (PEB) and Import Notice Declaration (PIB), filled out by the exporters/importers approved by the Customs & Excises Regional Offices and then send through Bank of Indonesia to Statistics Indonesia (BPS).

3. Trade System

Recording of Foreign Trade Statistics using the General Trade System or Special Trade System. Recording of Export Statistics using the General Trading and for recording of Import Statistics using the Special Trade System where PEB and PIB documents recorded from the entire ports of Indonesia.



4. Ruang Lingkup

Pencatatan Statistik Ekspor meliputi seluruh barang yang ke luar dari wilayah Republik Indonesia, baik yang bersifat komersial maupun bukan komersial seperti bantuan barang kredit lunak, hadiah dan sebagainya. Begitu juga dengan pencatatan Statistik Impor yaitu meliputi seluruh barang yang masuk ke wilayah Republik Indonesia kecuali wilayah bebas Batam.

5. Ekspor kapal laut dan pesawat udara termasuk dalam statistik ekspor sedangkan ekspor bunker oil untuk kapal tidak tercatat dalam publikasi ini. Sebagian impor kapal laut dan pesawat beserta suku cadangnya termasuk dalam Statistik Impor.

6. Barang-barang yang diolah di luar negeri tetap dicatat sebagai Ekspor, meskipun hasil olahan barang tersebut akan kembali masuk ke wilayah Indonesia. Barang – barang luar negeri yang diolah atau diperbaiki didalam negeri tetap dicatat sebagai barang impor, meskipun setelah barang tersebut selesai diproses akan kembali ke luar negeri (*re-Import*).

7. Barang-barang di bawah tidak termasuk dalam statistik Ekspor/Impor

- a. Pakaian dan barang-barang perhiasan penumpang

4. Coverage

The recording of export Statistics cover all goods leaving the territory of the Republic of Indonesia, both the commercial as well as non commercial goods, such as goods with soft loans, grants/gifts, etc. Also the recording of import Statistics covers all goods entering into the territory of Republic Indonesia except free area of Batam.

5. Ocean going ships and air planes are included in the statistics, while the export of bunker oil for ships is not presented in this publication. Some of the imported ship and aircraft and their spare part was included in the Statistics of Import.

*6. Goods processed abroad are still recorded as exports although the results of this processing will return to, and enter the territory of the Republic of Indonesia. Good overseas are processed or repaired in the country still recorded as imports, even though after the goods have been processed will be returned to foreign (*re-Import*).*

7. The following goods are not included in the statistic:

8. Sistem Pengolahan

Data dalam publikasi ini mencakup dokumen-dokumen ekspor dan impor tahun 2010 yang diterima Badan Pusat Statistik sejak awal Januari sampai 31 Desember 2011. Sistem pengolahan menggunakan sistem "carry over". Dengan metode ini dokumen-dokumen dari daerah ditunggu selama satu bulan setelah bulan berjalan. Dokumen yang datang terlambat akan dimasukkan dalam pengolahan bulan berikutnya. Metode "carry over" ini sangat membantu mempercepat pengolahan data, disamping itu telah diteliti bahwa

8. Processing System

The data in this publication cover export and import documents year 2011 received by the BPS since the beginning of January to December 31, 2011. The carry over system is applied in this processing. The deadline of the acceptance of the documents of a certain month is one month after the reference period, which means the end of the following month. The documents accepted after the deadline is considered as documents of the following month. The method of carry over was very helpful to speed up data processing, beside that it was researched

9. Klasifikasi Jenis Barang

Penggolongan barang di dalam publikasi ini menggunakan Klasifikasi Tarif Indonesia 1989 yang didasarkan atas HS (*Harmonized System*) yang sudah diperbaharui tahun 1991, 1993, 1996 dan yang terakhir tahun 2007. Versi yang terakhir mengalami perubahan yang relatif besar dibanding sistim pengkodean tahun sebelumnya. Disamping menggunakan HS sebagai klasifikasi jenis barang, juga digunakan SITC (*Standard International Trade Classification*) Revisi-3 yang digunakan secara meluas oleh banyak negara di dunia.

10. Periode Referensi

Periode penentuan ekspor adalah tanggal diberikannya izin muat barang tersebut oleh pejabat Kantor pelayanan Bea dan Cukai setelah diadakan pemeriksaan seperlunya. Periode penentuan impor adalah tanggal penyelesaian dokumen oleh pejabat-pejabat Bea dan Cukai yang terdapat dalam dokumen impor.

9. Commodity Classification

The classification of goods in the publication applies the 1989 Indonesia Tariff Classification, which is based on the HS (Harmonized System) which was updated in 1991, 1993, 1996 and last version in 2007. The latter one contains a significant change as compared to the previous version, and this is what it is applied in this publication. Besides applying the HS, the SITC (Standard International Trade Classification) third revision is also applied which has been used by many countries worldwide.

10. Reference Period

The period for export determination is the date of issuance of the Goods Loading Permit by the Customs & Excises Officer, after the necessary examination has been conducted. The period for import determination is the date issuance of the Goods Loading Permit by the Customs & Excises Officer that has been included in the import document.

11. Nilai Barang

Nilai barang yang dicatat untuk Statistik Ekspor adalah FOB (US\$) dan untuk Statistik Impor adalah CIF (US\$).

12. Satuan Barang

Satuan berat barang ekspor dan impor disajikan dalam berat bersih (Kg) .

13. Negara Tujuan

Yang dimaksud dengan negara tujuan adalah negara dimana barang-barang tersebut akan dikonsumsi/ diperdagangkan

14. Negara Asal

Yang dimaksud dengan negara asal adalah negara dimana barang-barang dihasilkan setelah diperiksa oleh pejabat Bea & Cukai sesuai dengan peraturan yang berlaku.

11. Commodity Valuation

The goods value recorded for the export statistics is the FOB value (US\$) and for import statistics is the CIF value (US\$).

12. Unit of Commodity

The unit of export and import commodity presented in net weight (Kg).

13. Country of Destination

Country of destination is the country known at the time of dispatch to be the final country where goods are to be delivered.

14. Country of Origin

Country of origin is the country known where the goods produced after the necessary examination by the Customs & Excises Officer with appropriate regulations.

**1. Neraca Perdagangan Sumatera Barat
Periode Tahun 2001-2011**

**1. Balance of Trade of Sumatera Barat Year
2001-2011**

Perkembangan neraca perdagangan Sumatera Barat sepuluh tahun terakhir cukup berfluktuasi dari tahun ke tahun. Nilai ekspor setiap tahunnya mendominasi perdagangan luar negeri Sumatera Barat sehingga selalu menghasilkan surplus neraca perdagangan. Kondisi pada tahun 2011 merupakan surplus neraca perdagangan tertinggi selama periode 2001-2011, yaitu sebesar US\$1.955.077 ribu atau mengalami peningkatan 33,60 persen dibanding neraca perdagangan tahun sebelumnya.

The growth of Sumatera Barat's balance of trade in the last ten years shows fluctuate from year to year. The value of exports always dominated the foreign trade of Sumatera Barat that generate surpluses in balance of trade. In 2011 is the highest surplus of balance of trade during 2001-2011 periods, which recorded U.S.\$1,955,077 thousand or increase 33.60 percent compared to previous year.

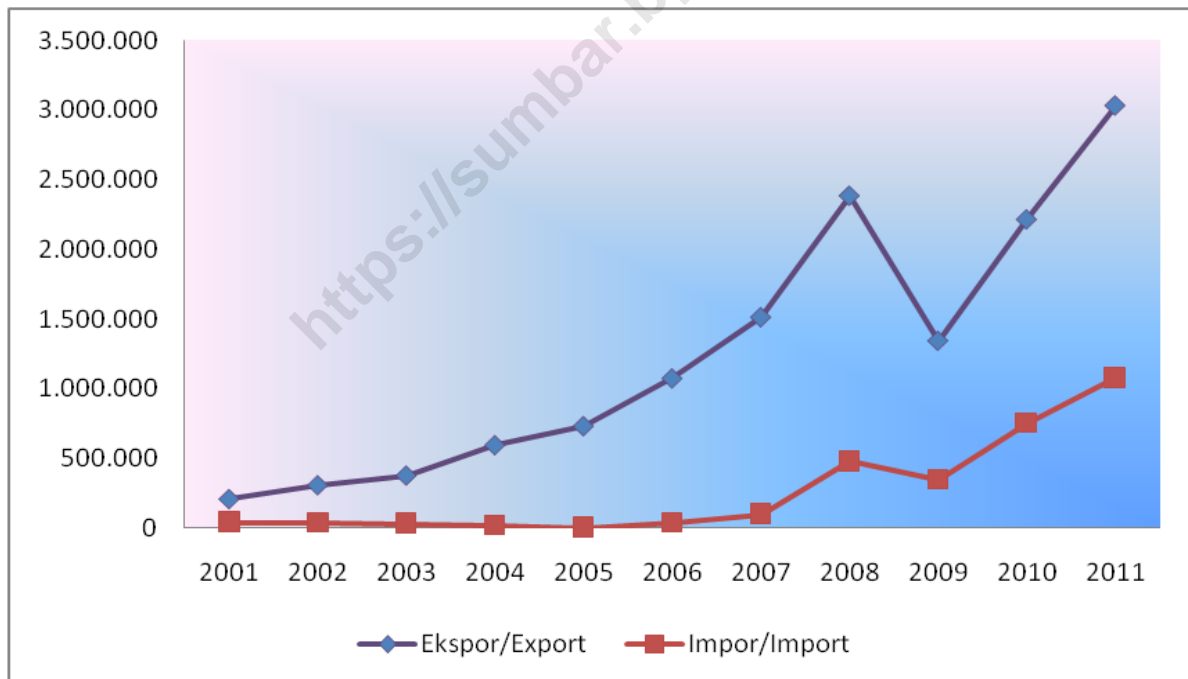

Nilai ekspor Sumatera Barat yang seluruhnya komoditi non migas pada tahun 2011 mencapai US\$3.031.815 ribu atau naik 36,89 persen dibanding tahun sebelumnya yang tercatat sebesar US\$2.214.774 ribu. Sementara itu nilai impor juga mengalami peningkatan 43,30 persen dibanding tahun sebelumnya, yaitu US\$751.377 ribu pada 2010 menjadi US\$1.076.738 ribu pada tahun 2011.

The value of export of Sumatera Barat which is all non oil commodity in 2011 recorded U.S.\$3,031,815 thousand or increase 36.89 percent compared to previous year which recorded U.S.\$2,214,774 thousand. Meanwhile the value of import in 2011 also increased 43.30 percent over the previous year, which recorded U.S.\$751,377 thousand in 2010 to U.S.\$1,076,738 thousand in 2011.

2. Perdagangan Sumatera Barat dengan Negara Mitra Dagang Utama Periode Tahun 2010-2011

Mitra dagang utama Sumatera Barat yang paling besar pada tahun 2011 adalah Amerika Serikat, India, China, Singapura, Malaysia, dan Belanda. Perdagangan dengan enam negara tujuan utama tersebut mencapai US\$2.765.127 ribu atau sekitar 91,20 persen dari seluruh nilai perdagangan luar negeri Sumatera Barat yang tercatat sebesar US\$3.031.815 ribu. Nilai ekspor ke enam negara tujuan utama tersebut dibandingkan dengan tahun 2010 mengalami peningkatan 38,39 persen dari US\$1.998.094 ribu menjadi US\$2.765.127 ribu.

2. Foreign Trade of Sumatera Barat With Main Trading Partner Country Year 2010 -2011

The largest major trading partners of Sumatera Barat in year 2011 is United State, India, China, Singapore, Malaysia, and Netherland. The trading with the six main countries reaches U.S.\$2,765,127 thousand, or approximately 91.20 percent of all foreign trade value of Sumatera Barat which is accounted as U.S.\$3,031,815 thousand. The export value to the six main countries increased 38.39 percent compared to that in 2010, from U.S.\$1,998,094 thousand to U.S.\$2,765,127 thousand.

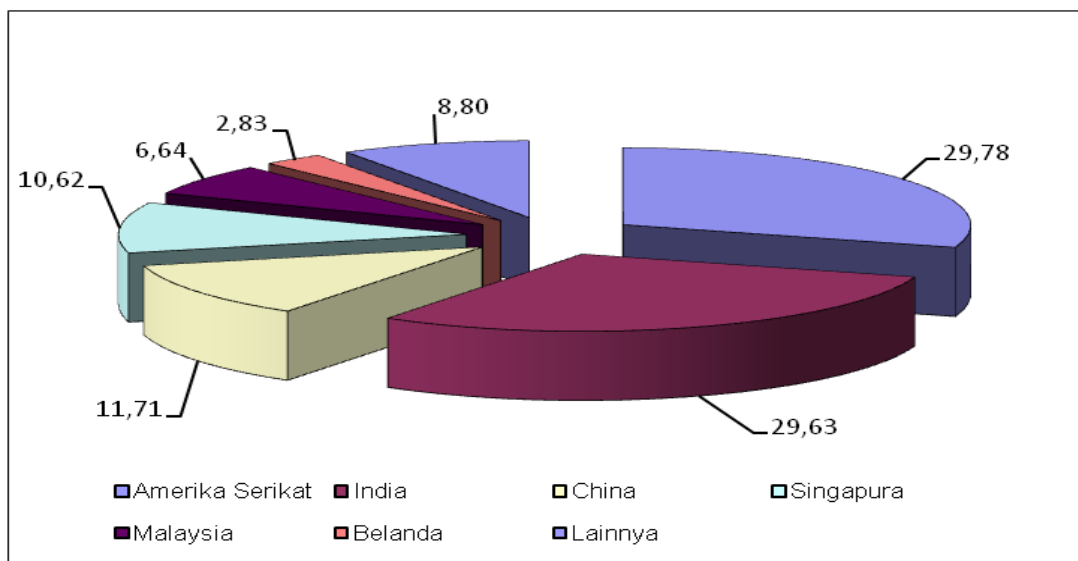

Perdagangan dengan Amerika Serikat tercatat sebesar US\$902.778 ribu atau sekitar 29,78 persen dari nilai keseluruhan perdagangan luar negeri Sumatera Barat. Sementara itu nilai ekspor dari negara-negara Asia seperti India sebesar US\$898.207 ribu (29,63%), China sebesar US\$354.992 ribu (11,71 %), Singapura sebesar US\$322.037 ribu (10,62%), dan Malaysia sebesar US\$201.194 ribu (6,64%). Untuk kelompok negara-negara Eropa, negara Belanda merupakan mitra dagang utama dengan nilai sebesar US\$85.918 ribu atau 2,83 persen. Namun demikian perdagangan luar negeri dengan negara-negara seperti Bangladesh, Pakistan, Rep.Tanzania, dan New Zealand juga tidak bisa diabaikan.

Trading with United States was recorded U.S.\$902,778 thousand or approximately 29.78 percent of the overall value of foreign trade in Sumatera Barat. The export value of Asian countries such as India is counted U.S.\$898,207 thousand (29.63%), China counted U.S.\$354,992 (11.71%), Singapore is counted U.S.\$322,037 thousand (10.62%), and Malaysia U.S.\$201,194 thousand (6.64%) . For the groups of European countries, Netherland has the largest trading value with U.S.\$85,918 thousand or 2.83 percent. However, trade with foreign countries such as Bangladesh, Pakistan, Rep. of Tanzania, and New Zealand also can not be ignored.

Sementara itu untuk nilai impor Sumatera Barat dari enam negara mitra dagang utama tersebut mencapai US\$938.820 ribu atau mencapai 87,19 persen dari total impor Sumatera Barat. Negara Singapura merupakan negara pengimpor terbesar mencapai US\$873.253 ribu atau 81,10 persen dari total impor Sumatera Barat. Sedangkan impor dari negara China dan India tercatat US\$56.471 ribu dan US\$5.605 ribu.

Instead the value of import of Sumatera Barat with the six largest major trading partner reached U.S.\$938,820 thousand or 87.19 percent of total imports. Singapore is the largest importer country which reached U.S.\$873,253 thousand or 81.10 percent of total imports. The value of imports from China and India, each recorded U.S.\$ 56,471 thousand and U.S.\$ 5,605 thousand
